**Schedule to Terms of Entry**

<b>Name of Competition</b>	Competitive Player Profile Registration Competition
<b>Promoter</b>	Tennis Australia Ltd (ABN 61 006 281 125) trading as Tennis Australia of Melbourne Park, Olympic Boulevard, Melbourne, Victoria 3000
<b>Permit Numbers</b>	Authorised under permits NSW Permit No. TP/02032, ACT Permit No. TP22/01422, SA Permit No. T22/1120
<b>Location</b>	Australia
<b>Entry Restrictions</b>	Entrants under 18 years of age must have permission to enter the Competition from a parent/guardian to be eligible to enter.
<b>Competition Period</b>	The Competition begins on <b>1 August 2022</b> AEST and ends on <b>30 November 2022</b> AEDT.
<b>Entry Method</b>	<p>Before the end of the Competition Period, entrants must:</p> <ul style="list-style-type: none"> <li>complete their existing player account <u>or</u> register a new player (if they do not already have a player account) via Tournament Planner and/or League Manager; and</li> <li>receive a valid Tennis ID and link their activated UTR rating profile.</li> </ul> <p>The Promoter may deactivate any player account which, in its sole discretion, it deems to be a duplicate of an existing player account.</p>
<b>Draw Details</b>	The draw will take electronically at Tennis Australia Headquarters, Melbourne Park, Olympic Boulevard, Melbourne, Victoria 3000 at 10:00 AM AEDT on 9 December 2022.
<b>Prize Details</b>	<p>10 x double passes to the 2023 Australian Open including:</p> <ul style="list-style-type: none"> <li>two tickets to a night session at Rod Laver Arena (the specific session will be advised by the Promoter to each winner when they are notified that they are a winner);</li> <li>Australian Open premium experience package;</li> <li>return economy flights from any capital city within Australia to Melbourne; and</li> <li>4 star twin share accommodation in Melbourne for one night.</li> </ul> <p>Each entrant is only eligible to win one double pass.</p>
<b>Total Prize Pool</b>	Each prize package is valued at \$2,000 AUD (incl. GST). The total prize pool is \$20,000 AUD (incl. GST).
<b>Notification of Winners</b>	Winners will be notified on 12 December 2022 via email using the email address provided in their player account.
<b>Publication Details</b>	Winners will be published on the Promoter's website and/or social media accounts within 30 days of the draw.
<b>Prize Claim Date and Time</b>	Prize/s must be claimed by 4:00 PM AEDT on 26 December 2022.
<b>Unclaimed Prize Draw</b>	<p>The unclaimed prize draw will be conducted online at 10:00 AM AEDT on 29 December 2022 and the winner will be notified on 30 December 2022 via the same methods as the original draw. Subsequent winners of the unclaimed prize draw will be published on the Promoter's website and/or social media accounts.</p> <p>The prize for the unclaimed prize draw must be claimed by 4:00 PM AEDT on 4 January 2023. If the winner of the unclaimed prize draw does not claim the prize by this time and date, then there will be another draw at 10:00 AM the following day. This process will continue until all prizes are claimed.</p>
<b>Prize Delivery</b>	The tickets for the prize will be delivered to each winner no later than 9 January 2023.

## Tennis Australia Trade Promotion: Game of Chance

1. These terms must be read together with the Schedule for the Competition which defines certain terminology used in these terms. Entry into the Competition is deemed acceptance of these terms.

### **Eligibility to Enter**

2. Entry is only open to persons residing in the Location who comply with the Entry Restrictions (if applicable). Entrants can only enter in their own name. The Promoter reserves the right to request winners to provide proof of age, identity and residential address, by any means which the Promoter considers suitable for verification, in order to claim a prize. In the event that a winner cannot provide suitable proof, that winner will forfeit their prize in whole and no substitute will be offered.
3. Officers, contractors, employees and their immediate families of the Promoter or any of its related bodies corporates, or of its agencies or contractors involved with this Competition are ineligible to enter.

### **Entry**

4. To enter the Competition, entrants must follow the Entry Method during the Competition Period. All entries received after this time are ineligible for entry into the Competition and no responsibility will be accepted by the Promoter for lost, late, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries claims or correspondence.
5. All eligible entrants will go into the draw. The draw will be conducted in accordance with the Draw Details. The Prize will be awarded to valid entrants randomly drawn in accordance with the Prize Details.
6. The draw and all matters pertaining to this Competition are final. No correspondence will be entered into.
7. The Competition is a game of chance.

### **Prize**

8. The prizes are specified in the Prize Details. The total prize pool is specified in the Total Prize Pool section of the Schedule.
9. The prizes are not transferable, exchangeable or redeemable for cash. The prize values are accurate at the date of commencement of the Competition. The Promoter accepts no responsibility for any variation in the value of a prize after that date. Refunds will not be made in respect to unused services or prizes. Where a prize, or part of a prize, is unavailable, the Promoter retains the right to substitute the prize (or part) with a prize (or part) of equal or greater value subject to relevant State and Territory regulations.
10. In the event that, for any reason whatsoever, a winner does not take an element of the prize at the time stipulated by the Promoter, then that element of the prize will be forfeited by the winner and cash will not be awarded in lieu of that element of the prize.
11. All costs associated with a prize not specifically included in the Prize Details, including but not limited to any transport costs, transfer costs, meals, taxes, insurance and other ancillary costs are the responsibility of the winner (and their companion).
12. If a prize includes tickets to an event, all tickets are valid for the date or period as indicated on the tickets. All event tickets are issued subject to the relevant event ticket conditions of sale and entry. circumstances.

13. If a prize involves the winners meeting or attending a function with a celebrity or other public figure, the Promoter will not be liable for the failure of a winner (and their companion) to meet that person or failure of that person to attend the function, for whatever reason.
14. If a prize includes domestic travel, the prize must be booked and completed as specified by the Promoter. Any flights and accommodation constituting part of a prize are subject to booking and availability. Any tickets, passes or vouchers issued as part of the prize are subject to the prevailing terms and conditions of use. They are only valid for use within the stated duration on the tickets, passes or vouchers issued and are not replaceable if lost, stolen or damaged. The Promoter is not responsible for any cancellation, delay or re-scheduling of flights and any costs incurred as a result (including without limitation accommodation costs) will be the sole responsibility of each winner.
15. The winners (and their companions) will be responsible for meeting all the entry requirements as well as any health or other government requirements for travel including travel authorisations, medical advice and recommended vaccinations. Failure to fulfil these requirements may result in the prize being forfeited or any additional costs being incurred at the expense of each winner (and their companion). The winners (and their companions) agree to comply with any prevailing terms and conditions of the relevant transport carrier, accommodation provider, service provider, insurance provider and in particular any health, behaviour, age and safety requirements.
16. If a winner of a prize is under the age of 18 years, the winner must be accompanied by their parent or guardian whilst taking part in the prize.

## **Notification and Collection of Prizes and Redraw Process**

17. The winners will be notified in accordance with the Notification of Winners and will have their full name and state of residence published in the manner set out in the Publication Details.
18. The winners must confirm their eligibility and contact the Promoter by the Prize Claim Date and Time. In the event that a winner is unable to be contacted, and all methods of communication are unsuccessful, the relevant winner will forfeit their prize and the Promoter reserves the right to conduct such further draws on the Unclaimed Prize Draw Date as are necessary to distribute the prizes, subject to any directions given by any relevant authority. If required by law or any relevant authority, the winners will have their name and state of residence published in accordance with the Unclaimed Prize Draw Publication Details. If a prize is no longer capable of being redeemed, the new winner/s will receive a prize, as determined by the Promoter, of equivalent value (as if the original prize had been awarded to that person, less any administrative expenses incurred by the Promoter), subject to the approval of the relevant authorities in the Location if required. If no Unclaimed Prize Draw Date is specified, any unclaimed prize/s will be distributed at the Promoter's discretion.

## **Privacy**

19. By entering the Competition, you consent to the collection, storage, use and disclosure of your personal information in accordance with the tennis privacy statement located at <http://www.tennis.com.au/privacy-statement> and the tennis privacy policy located at <http://www.tennis.com.au/privacy>, which contain information about how you may access and seek correction of your personal information, how you can complain about a breach of your privacy and how the complaint will be dealt with. If you do not agree, you must not provide your personal information, and you will be ineligible to be selected as a winner.
20. Each entrant must ensure that any other person whose details have been provided by the entrant to the Promoter for the purposes of the Competition has given their implied or express consent for their details to be provided to the Promoter and any of its related bodies corporate and to be contacted by the Promoter

Entrants provide their information to the Promoter and not to Instagram or Facebook.

## **COVID-19**

22. The winners (and their companions) must comply with any relevant COVID-19 related directions, orders or restrictions in force in the relevant State or Territory at any time whilst taking part in the prize as well as any other biosecurity requirements notified by the Promoter and any transport carrier, accommodation provider and/or service provider delivering any element of the prize.

## **Discontinuance and Disqualification of Competition**

23. The Promoter reserves the right to discontinue the Competition at any time and at its sole discretion may cancel, terminate, suspend or modify the Competition and/or, if necessary, provide an alternative prize or prizes to the same value as the original prize. Any change to or cancellation of this Competition, for whatever reason, is subject to the written direction of all relevant legislative departments in the Location.

Without limiting the foregoing, the Promoter reserves the right in its sole discretion to verify the validity of entries and to disqualify any entrant who, in the opinion of the Promoter, has not complied with or has breached any part of these terms or otherwise engaged in unlawful or improper conduct in relation to the Competition.
