PRACTICE

Plexicushion practice courts will be available, weather permitting, from Tuesday 17th January 2012 at the Traralgon Tennis Association once the Loy Yang Traralgon Junior International is down to its final two days.

Albert Park Reserve (opposite the Bayview Hotel on the corner of St Kilda Rd and Hanna St, Melbourne) will be available for juniors to practice at from Saturday 21st January 2012.

Practice at Melbourne Park will not be available until Sunday 22nd January 2012.

All practice court bookings can be made at the tournament desk at the Traralgon Tennis Association.

WITHDRAWALS

Main Draw and Qualifying Withdrawal Deadline is 2.00pm (GMT) on Tuesday 10th January 2012. This is 1.00am (AEDST) on Wednesday 11th January 2012.

Late withdrawals will be penalized on accordance with the Junior ITF Code of Conduct. All withdrawals must be made in writing. Players are advised to keep a paper copy of any withdrawal made. It is the responsibility of the sender to ensure that the withdrawal has been received.

MEALS

A meal allowance of \$35.00 per day will also be placed on players' accreditation commencing **Sunday 22nd January 2012**, until and including the day the player is eliminated from the tournament.

Photo passes must be shown for each food purchase. Once the daily allowance has been spent the difference must be paid for in cash.

DAILY ALLOWANCES

Each main draw player and official National Federation coach staying at the tournament hotel is entitled to the daily allowance to cover accommodation, breakfast and dinner commencing the night of Saturday 21st January, until and including the day the player is eliminated from the tournament. Breakfast allowance for the day following elimination will also be provided.

Daily allowances are available to a maximum of two coaches, one boy's coach and one girl's coach, per Federation. Only coaches nominated by their Federation and whose application is received by Tuesday 13th December 2011 will be granted hospitality. No other coaches or accompanying persons shall be guaranteed hospitality.

Official tournament hospitality for coaches and players must be booked separately and bedrooms must not be shared. Requests to share accommodation by players and coaches from the same or opposite sex will be refused. The only exception allowed to this rule is when a National Association nominates a parent as the official coach.

Each player and coach is responsible for paying their own hotel account. Daily allowances will be paid upon presentation of the paid hotel account to the Tournament Director. Hotel accounts must be in the name/s of all persons seeking daily allowance payments and must be received before Saturday 28th January 2012.

Request for daily allowances at hotels other than at the tournament hotel will be considered individually. Daily allowances are not available to players who live in Melbourne or who are staying privately with families.

IPIN

It is a compulsory requirement for all players entering and participating in ITF Junior Circuit tournaments to have an IPIN **and** to have paid an annual IPIN membership fee.

The cost to a junior player for an IPIN Membership is US\$30.00 per year. Any junior player who wishes to compete on an ITF Pro Circuit tournament will have the option to pay the full IPIN membership fee, which is US\$55.00, at the start of the calendar year or can upgrade to this level at any stage during the year by paying the US\$25.00 difference.

Players must register for their IPIN at www.itftennis.com/IPIN and pay the fee using a credit card. Any player (including on-site alternates) who enters a tournament without a valid IPIN and without paying the IPIN membership fee will have his/her entry rejected.

CODE OF CONDUCT

The ITF Code of Conduct will be used during the tournament.

The point penalty schedule for violations is:

First Offence	Warning
Second Offence	Point Penalty
Third Offence	Game Penalty

However, after the third Code Violation, the ITF Referee shall determine whether each subsequent offence shall constitute a default.

LUCKY LOSER

Players who lose in qualifying, but who wish to be considered for any lucky loser positions in the Main Draw Singles, must sign-in and obtain **Lucky Loser details** at the Traralgon Tennis Association on Friday 20th January 2012.

SINGLES QUALIFYING AND MAIN DRAW DOUBLES

Players in singles qualifying who wish to be considered for main draw doubles must sign-in and obtain details at the qualifying venue on Thursday 19th or Friday 20th January 2012.

SCHEDULING

Matches will be scheduled on a "followed-by" basis.

FORMAT

Singles matches will be the best of three sets. First two (2) sets a tiebreak, third set advantage.

Doubles matches will be Best of 2 tie-break sets. If one set all, a match tie-break (10 point) will be used to decide the match. Games will feature no ad scoring.

MATCH CONDITIONS

For main draw matches, six balls will be provided on court with a change at 7 and 9 games. There will be a chair umpire provided for every match. There will be at least four linespersons for every match. There will be at least three ballpersons provided for every match.

MATCH CALLS

Matches will be called from Tournament Control on the public address system that can be heard only in the dressing rooms, player café, lounge and tournament control.

It is each player's responsibility to go to court upon hearing his or her match called. The 15 minute default rule shall apply from the time the match is called.

Please note players will need to be ready to play as soon as their name is called due to the distance between Hisense Arena and match courts.

PRESENTATIONS (INCLUDING GARDEN SQUARE PRESENTATION CEREMONY)

Trophies will be awarded to the winners and finalists of the singles and doubles events. Players receiving awards are expected to be available for the presentations at the conclusion of their match.

In addition, Tennis Australia will be recognising the winners of all junior events in a special evening ceremony to be held at Garden Square in Melbourne Park in the lead-in to the night session matches on Rod Laver Arena. We would

like all singles and doubles winners to be available for this special presentation.

The winners of the Boys and Girls Junior Singles & Doubles events will be presented with awards in Garden Square on Saturday 28th January at 6:30pm.

DAILY SCHEDULE

The schedule of play will be released by the Tournament Referee as part of the complete Australian Open schedule.

It will be posted on the AOJC Office noticeboard by 7pm each night. Every effort will be made to post the schedule earlier if possible. A copy will also be displayed at the Bayview on the Park hotel each night.

AO HEAT RELATED GUIDELINES

The Australian Open Extreme Heat Policy will be applied at the Referee's discretion and may be altered at any time;

At the Referee's discretion, when the Wet Bulb Globe Temperature only (WBGT) is equal to or above the pre determined threshold, the Tournament Referee may suspend the commencement of any further matches on outside courts;

The WBGT reading will be closely monitored by the Tournament Referee and the EHP will be implemented at his discretion;

Any matches currently in progress will continue until the end of the current set. At the completion of the set, play will be suspended;

Where play in any match commences outdoors (or with a roof open) and the WBGT temperature is equal to or exceeds the pre determined threshold, the match will continue until the completion of the set. At the end of the set a decision may be made by the Referee to close the roof for the remainder of the match and the following matches, when the EHP is still in effect (on Rod Laver Arena and Hisense Arena);

A roof will only be closed because of extreme heat if a decision has been made by the Referee to suspend the completion or commencement of matches on the outdoor courts;

When the EHP has been implemented, the Tournament Referee will suspend the calling of any further matches on outside courts;

Supplement: In the Women's Singles, to allow a 10 minute break between the 2nd and 3rd sets when a WBGT 30.1 reading has been recorded prior to the calling of the match by Tournament Control. Readings are continually made throughout the day.

For Junior Singles, to allow a 10 minute break and Wheelchair Singles to allow a 15 minute break between the 2nd and 3rd sets, this will be applied at the Referee's discretion at a pre determined threshold, prior to the calling of the match by Tournament Control. Readings are continually made throughout the day.

The break will not apply between the second and third sets if play had previously been suspended after the first set due to EHP. Ice Vest Policy, when the Wet Bulb Globe Temperature (WBGT) is equal to or above 26, ice vests are to be distributed to the courts. Chair Umpires are to make the players aware of the availability of the ice vests.

Supplement for Women's Singles and Junior Singles only, to allow a 10 minute break between the 2nd and 3rd sets when a WBGT 28 reading has been reached prior to the calling of the match by Tournament Control. Readings are continually made throughout the day.

The 10 minute break will not apply between the 2nd and 3rd sets, if play had previously been suspended after the 1st set due to the EHP.

ACCREDITATION

Each junior Main Draw competitor and Official National Federation Coaches (one boys & one girls coach) will be issued with a photo accreditation which provides access to Melbourne Park and the Hisense Arena player facilities area.

Main draw players may also nominate any two (2) guests for photo accreditation, which can be issued at the same time. Photos will only be taken at the accreditation office from **Friday 20th January 2012**. You will need to report to the **Satellite Accreditation** (next to Hisense Arena at Melbourne Park) before gaining access to Melbourne Park and the accreditation office.

The photo accreditation pass gives access to the grounds and the basement level player facilities area of Hisense Arena and administration areas of Rod Laver Arena only from the day of issue till the completion of the AOJC.

For day and night sessions inside Rod Laver Arena and Hisense Arena, players may be able to obtain a ticket from the AOJC Office **if** available. Photo accreditation passes will not allow players, coaches or guests access inside the main arenas.

Each main draw competitor may request one (1) complimentary Ground Pass for family or friends. Their pass will be valid for the day of issue. Ground passes provide access to outside courts only. The ground pass will be given to players upon request and will be subject to approval by the AOJC Tournament Director and availability.

A. TERMS AND CONDITIONS OF ACCREDITATION

In consideration of being granted the right to enter Melbourne Park (MP), including designated restricted access areas, all accredited entrants are required to abide by the Australian Open Ticket Conditions of Sale and Entry, and the following Accreditation terms and conditions:

1. Accreditation is a privilege not a right which Tennis Australia (TA) may withdraw at any time. Guest Passes are available to players' legitimate guests (in good faith) and subject to the 2012 Australian Open Player and Player Affiliated Groups Accreditation Policy. A Player must not receive any direct financial or other benefit as consideration for nominating a guest for accreditation.
2. Passes are non-transferable and must be worn correctly at all times with photo clearly visible.
3. Access is restricted in accordance with TA approved activities only, including any future directions which may be given from time to time.
4. MP Emergency Procedures must be adhered to at all times.
5. All accredited entrants agree to the Australian Open Ticket Conditions of Sale and Entry displayed at all venue entry points, including agreeing to enter MP at their own risk. Melbourne & Olympic Parks Trust (MOPT) and TA will not be liable for any injury, loss or damage suffered by any person at MP.
6. Australian Open officials can lawfully direct accredited entrants during the Australian Open period (including bump in and bump out).
7. All accredited entrants must:
 - not take unauthorised photos, video stills or video footage within restricted areas of the venue and only take photos, video stills or video footage as permitted by the Australian Open Ticket Conditions of Sale and Entry;
 - not request autographs;
 - not leave dependent children unsupervised;
 - comply with the prohibitions on gambling and betting as set out in 8 below.
8. (a) For Players and their "Related Persons" (defined as 'any coach, trainer, therapist, physician, management representative, agent, family member, tournament guest, business associate or other affiliate or associate of any Player, or any other person who receives accreditation at an Event at the request of the Player or any other Related Person') – and "Tournament Support Personnel" (defined as 'any tournament director, owner, operator, employee, agent, contractor or any similarly situated person at any Event') including but not limited to Tennis Australia employees, agents, contractors and sub-contractors, or those with access classifications (Number Access) 2, 3, 7, 8 or (Icon Access) Change Room, Player Cafe (including Temporary Access Stickers):

I acknowledge that the ITF has a Uniform Tennis Anti-Corruption Program and the Program rules are included in the 2012 Official Grand Slam® Rule Book. I accept that I must comply with and be bound by all provisions included in the Uniform Tennis Anti-Corruption Program. The Uniform Tennis Anti-Corruption Program prohibits certain

conduct by a player and their "related persons", as defined in the rule, including, but not limited to, (i) wagering on any tennis match, (ii) contriving or attempting to contrive the outcome of any tennis match, (iii) providing for consideration information concerning the condition or status of players, and (iv) the failure to report to the Tennis Integrity Unit as soon as possible any knowledge I may have regarding potential violations of the Uniform Tennis Anti-Corruption Program. Nothing in this paragraph shall modify or limit the full text of the Uniform Tennis Anti-Corruption Program.

(b) For all other accreditation holders – Accreditation holders must not gamble or bet on tennis in relation to the Australian Open or on any activity in relation to the Australian Open, whether directly or indirectly, or supply otherwise private information to another aiding the other party's gambling. [Note – applies to TA staff, agents, contractors and sub-contractors; TA Affiliates; Australian Open Tournament staff; or those with access classifications (Number Access) 2, 3, 7, 8 or (Icon Access) Change Rooms (including Temporary Access Stickers).

9. TA staff, agents, contractors and sub-contractors and Australian Open Tournament staff must abide by the Tennis Australia Media Spokesperson Policy, Tennis Australia Social Media Policy, Australian Open OH&S Rules and any other relevant policies and procedures. For the avoidance of doubt, the Social Media Policy does not apply to accredited media and broadcast representatives, Players and their Related Persons.
10. If TA requires, accredited entrants must participate in and/or provide evidence of background checks, including but not limited to national police checks/
11. TA may alter these terms and conditions of accreditation if such changes are reasonably necessary to address safety issues or otherwise protect legitimate interests of TA or MOPT.

B. TERMS AND CONDITIONS OF PLAYER PARTICIPATION IN AUSTRALIAN OPEN 2012

1. In consideration of Tennis Australia accepting my entry in Australian Open 2012, I acknowledge and agree to be bound by any relevant policies or terms and conditions as set down by Tennis Australia. Moreover, as a player I understand and acknowledge that as a condition to receiving my accreditation, I will by way of acceptance, be required to sign the Player Registration Form.
2. In consideration of Tennis Australia accepting my entry into and allowing me to participate in Australian Open 2012, I grant and assign to Tennis Australia, official Australian Open broadcasters, media partners, sponsors, suppliers and other commercial partners, and any other applicable third party reasonably nominated by Tennis Australia from time to time, the irrevocable, world-wide, perpetual and royalty-free right and license to make, show,

produce, film, photograph, reproduce, publish, broadcast, transmit, display, communicate and otherwise use, at their discretion (for any purpose whatsoever and through or in connection with any medium, platform or form of communication, broadcast or transmission including television, internet and mobile telephony), any and all motion pictures, still pictures and live, taped or filmed coverage, footage, television, sound recordings and any other reproductions of any description of me taken, captured, filmed or produced during or in connection with the Australian Open (including the main and qualifying draws). I agree that my name, voice, likeness, image and biographical material may also be used and reproduced in any way including but not limited to for the purposes of providing information and news in relation to the tournament, audio visual coverage, distribution and broadcast of the tournament, archival purposes, and publicising, promoting and advertising Tennis Australia and the Australian Open (and the third parties referred to above in this clause 3 for these purposes). I acknowledge that the usages described in this clause 3, including for commercial purposes, is without compensation to myself, heirs, devisees, executors, administrators or assigns.

3. Further, in consideration of Tennis Australia accepting my entry into Australian Open 2012, I agree to cooperate with the media and to participate upon request by Tennis Australia, in reasonable promotional activities for the tournament including:

- pre-match and post-match interviews
- requiring my coach to be available for televised pre-match, during match and post match interviews
- pre-event functions or events including pre-event press conferences
- press conferences, interviews, and the winners' presentation and photo shoot

My participation in such activities as a player shall not be represented as an endorsement by me of any product, service or company.

4. Medical information: for the purpose of this authorisation 'personal medical information' means a player's entire past, present or future health or medical records in any form.

By signing this document, I acknowledge and authorise:

- a) all health care providers, who have or may have personal medical information about me, to use and/or disclose such information to the primary health care providers of Tennis Australia while this authorisation is in effect; and
- b) the use and disclosure of all my personal medical information (whenever relevant) by Tennis Australia to the ITF/ATP/ WTA (as applicable).

This authorisation is effective until the date on which my affiliation with the ITF/ATP/WTA (as applicable) is terminated. It may be revoked at any time, but not retrospectively, by written request forwarded to Tennis Australia.

5. Tennis Australia undertakes not to disclose any players' personal medical information except in accordance with this authorisation and/or pursuant to the national privacy principles. I further acknowledge that, without limiting and subject to clause 6, any of my personal information collected by Tennis Australia at or in connection with the Australian

Open (including my entry into that tournament) is collected with my full and free consent, and may be used for this purpose and related purposes, which can be reasonably expected (including the provision of player and associated services). I understand that this information will not otherwise be disclosed to third parties without my consent, and that I may access my personal information through Tennis Australia upon giving reasonable notice.

6. In consideration of Tennis Australia accepting my entry, I acknowledge the risks associated with participating in Australian Open 2012, accept those risks voluntarily and I release and discharge (on behalf of myself, heirs and legal representatives), Tennis Australia, its officers, directors, employees and representatives, of and from any and all claims, demands, suits, damages, costs (including legal costs), loss and injury I may suffer or sustain, by negligence or otherwise, to the fullest extent permitted by law in connection with or related to any and all aspects of Australian Open 2012.
7. I declare to be aware of and will abide by the Rules of Tennis as approved by the International Tennis Federation, the Grand Slam Tournament Regulations, and the Grand Slam Code of Conduct, as amended from time to time by the Grand Slam Committee (GSC). I otherwise agree to comply with all relevant ATP, WTA, ITF and Tennis Australia policies, by-laws, regulations and rules at all times whilst participating in the Australian Open.
8. I am aware of, and accept, that I may be required to undergo drug testing as a result of the ITF Anti-Doping Program, Australian Government (including the Australian Sports Anti-Doping Authority) or other binding regulations imposed upon the event by authorities outside its control or in accordance with a drug testing program approved by the GSC ("relevant bodies"). I accept that I must submit to the jurisdiction of these relevant bodies to enforce these drug testing programs (including the ITF Anti-Doping Program).
9. I acknowledge that Tennis Australia may deduct stringing and other applicable costs incurred by me throughout the tournament from the per diem that I will otherwise receive.
10. I am aware that my coach, trainers, other guests and I are strictly prohibited from taking any motion pictures, still pictures, sound recordings and any other reproductions of any description any by any means whatsoever in any area of Melbourne Park including but not limited to the locker rooms, and all accreditation restricted administration areas. I agree to use reasonable efforts to ensure that my coach abides by this prohibition.
11. I acknowledge that the International Tennis Federation has a Uniform Tennis Anti-Corruption Program and the Program rules are included in the 2012 Official Grand Slam Rule Book and on the 2012 Australian Open website. I accept that I must comply with and be bound by all provisions included in the Uniform Tennis Anti-Corruption Program. The Uniform Tennis Anti-Corruption Program prohibits certain conduct by me and my "related persons", as defined in the rule, including, but not limited to, (i) wagering on any tennis match, (ii) contriving or attempting to contrive the outcome of any tennis match, (iii) providing for consideration information concerning the condition or status of players, and (iv) the failure to report to the Tennis Integrity Unit as soon as possible any knowledge I

may have regarding potential violations of the Uniform Tennis Anti-Corruption Program. Nothing in this paragraph shall modify or limit the full text of the Uniform Tennis Anti-Corruption Program.

12. I agree to be respectful of Australian Open sponsors and suppliers. Moreover, I will not publicly voice an endorsement or acknowledgement of any product, service or company while participating in any official tournament ceremony or any activities mentioned under section 3 above.
13. I understand and acknowledge that my accreditation: (1) shall be valid from the time its issued until the end of the Tournament, and (2) is non-transferable and must be visibly worn at all times while inside the Melbourne Park precinct.
14. Without limiting any of the above, I agree:
 - a) to compete at the best of my ability at all times throughout the Australian Open and attend and participate in all tennis matches which I am schedule to play (subject to injuries I may have or sustain); and
 - b) not to engage in any conduct or do anything that is or is likely to bring Tennis Australia or the Australian Open into ridicule or disrepute,
15. I understand that (1) entry through the ITF in no way diminishes the application of the above rules; and (2) I will not be allowed to participate in any competition at Australian Open 2012 until the entry form and this Player Registration Form have been signed by me. These conditions and any disputes relating thereto shall be construed in accordance with the laws of the State of Victoria, Australia, and the player agrees to submit to the exclusive jurisdiction of the courts of Victoria, Australia. I declare the information on this document is complete and correct.

C. USE OF OFF-SITE GYMNASIUM FACILITIES

In this agreement

"Claim" means and includes any action, suit, proceeding, liability, claim, demand, losses, damage, cost or expense however arising including but not limited to negligence.

"Gym activities" means the use or enjoyment of the Collingwood Football Club gymnasium.

"MOPT" means Melbourne and Olympic Parks Trust and where the context provides, includes its directors, employees, contractors and agents.

"TA" means Tennis Australia Limited trading as Tennis Australia and where the context provides, includes its directors, employees, contractors and agents.

"CFC" means the Collingwood Football Club and where the context provides, includes its directors, employees, contractors and agents.

"CFC Gymnasium" means the Gymnasium equipment and facilities located at the Westpac Centre.

I have voluntarily read and understood the notice included as part of this document.

Release and indemnity: in consideration of being provided with access to Gym activities and my participating in Gym activities, I agree that, to the extent permitted by law:

- (a) I release TA, MOPT and the CFC from all claims that I may have or may have had but for this release arising from or in connection with my participation in any Gym activities.
- (b) I agree to indemnify, defend and hold harmless TA, MOPT and the CFC in respect of any claim by any person arising as a result of or in connection with my participation in any Gym activities.

Fitness to participate: I declare that I am medically and physically fit and able to participate in any Gym activities. - (d) Athlete Management System ("AMS") - electronic storage of medical records
Tennis Australia's Athlete Management System (AMS) is a repository of personal information and other medical details ("Database Information") of Australian Open players. In storing Database Information in and using the AMS, Tennis Australia requires the consents set out below.
- (e) Tennis Australia not responsible for treatments
Tennis Australia permits and facilitates the services described in A to D above as they are essential for players during a tournament. However, as Tennis Australia is not actually itself providing the relevant treatments and/or services, Tennis Australia does not accept any responsibility or liability for such treatment or services provided by medical or allied/other health service providers on-site at Melbourne Park during the Event (including any Official Providers, ATP/WTA Tour athletic trainers and physiotherapists, a player's own private physiotherapist, massage therapist or trainer, and/or TA arranged radiologists). Such medical and allied/other health providers provide these services at their own risk and responsibility. Given this, Tennis Australia requires the release set out below.
