

Terms and Conditions of Entry - National Indigenous Tennis Carnival 2024

These conditions govern access to the National Indigenous Tennis Carnival 2024 (NITC) held by Tennis NT. By entering the NITC, you agree to be bound by these conditions.

- 1. Entrance pass.** Upon accepting these terms and conditions, you will be provided with a pass that provides you access to the NITC. Your pass remains the property of Tennis NT and must be returned upon Tennis NT's request for any reason. Receiving your pass does not guarantee that you will be entitled to retain it throughout the NITC. Unless specifically authorised by Tennis NT, you:
 - a) must not transfer your pass to any other person.
 - b) must always wear your pass visibly while attending the NITC.
 - c) must abide by all directions given to you by Tennis NT.
- 2. Prohibited conduct.** For the comfort and safety of patrons and players, the following conduct is NOT permitted in the NITC without the express authorisation of Tennis NTC:
 - a) any photography of children that are not in a patron's immediately family or guardianship;
 - b) removing children from their playing group during the event;
 - c) removing children from the NITC venue at any stage during the event;
 - d) conduct towards any player, umpire, referee, other official or another patron in a manner which does, or is likely to, offend, insults, humiliate, intimidate, threaten, disparage or vilify that other person;
 - e) disruption or interruption to any match or other event or activity at the NITC (i.e. only spectating the tennis matches and not participating in any way);
 - f) damaging or defacing of any part of the NITC venue or any other person's property;
 - g) unreasonable disruption or interference or obstruction to patrons or Tennis NT or other persons engaged in the operation of the NITC;
 - h) conducting public surveys or opinion polls, handing out promotional items, soliciting donations or subscriptions, other commercial or political disruption;
 - i) removal of footwear, shirts or public nudity/indecency; and
 - j) concealing identity with a scarf, balaclava, mask or other item unless for a religious, medical or other justifiable reason.
- 3. Prohibited areas.** You acknowledge that Tennis NT maintains the right to restrict public access to certain areas at certain times during the NITC. Any such restrictions will be appropriately communicated during the event.
- 4. Smoking.** You must not smoke or vape within the NITC.
- 5. Capture and use of image and personal information.** Unless you expressly notify us otherwise in writing, you consent to being photographed, filmed and recorded at the NITC. You acknowledge that in order to enhance security, surveillance equipment (including security cameras) are used in and around the NITC. You also consent to the use of any film, image or recording of you or any other personal information obtained by Tennis NT at the NITC in accordance with the tennis privacy statement (located at <http://www.tennis.com.au/privacy-statement>) and the tennis privacy policy (located at <http://www.tennis.com.au/privacy>), which contain information about how you may access and seek correction of your personal information, how you can complain about a breach of your privacy and how the complaint will be dealt with. Tennis NT may from time to time disclose your personal information to, its commercial partners, broadcasters, media and news agencies, and law enforcement agencies without compensation or further notice.
- 6. Risk.** You enter the NITC at your own risk and voluntarily accept there are inherent risks in attending such events. Except to the extent that Tennis NT is at fault or to the extent that the ACL applies, you release Tennis NT from any liability (including without limitation, loss of or damage to property, or personal injury sustained during activities) in connection with your attendance at the NITC.
- 7. Changes.** Tennis NT may alter these terms and conditions at any time if such changes are reasonably necessary to address safety issues or otherwise protect the legitimate interests of Tennis NT.
