## NOMINATION PROCESS:

A nominee must complete and provide the attached "Director Nomination Form 2024" and provide it to the CEO at least one week prior to the AGM (by the 9th of November, 2024).  
Section: 28.1

A nominee must have their nomination proposed and seconded by member delegates not from the same member. Section: 28.2

For example, an existing Tennis NT Director at the end of their term can nominate themselves and have their nomination seconded by any of the Member Delegates listed.

An existing member delegate (the group listed) can nominate themselves and have their nomination seconded by another Member Delegate. Note that a Member Delegate who becomes a Tennis NT Director would then step down from their other position.

An eligible person who is not an existing Tennis NT Director at the end of their term, nor a Member Delegate listed above, would require a nomination and second nomination from the Member Delegates listed.
