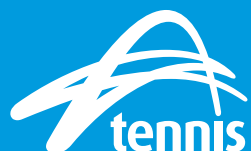

# School Partnership Program Agreement ('Agreement')



By signing this Agreement, Tennis Australia Limited (TA), the School, Program Partner agree to comply with the terms and conditions set out below. This Agreement sets out the terms and conditions which apply to the delivery of any of Tennis Australia's tennis programs at the School, including Tennis Hot Shots **Program**. Where the Program Partner is a club, all references to the Program Partner include that Program Partner's employees and personnel.

## Benefits provided to the School

In consideration of the School complying with its obligations, TA will provide the School with the following benefits:

- a. an initial Program specific equipment pack
- b. free participation for teachers at yearly professional learning run by TA;
- c. an equipment replenishment gift provided to the School upon completion of the yearly School participation survey
- d. ability to purchase discounted tennis equipment through the online store;
- e. ability to apply for the National Court Rebate funding;
- f. quarterly e-newsletter communication;
- g. Program branding suite including logo;
- h. ability for a nominated teacher of the School to win a trip to the Australian Open (AO) Grand Slam Teachers Conference held each year;
- i. ability for the School to be nominated for the 'Newcombe School of the Year Award.' All finalists will be flown to Melbourne for the Newcombe Medal event; and
- j. ability for a Program participant to win a "Kids on Court" experience at the Australian Open (AO) and AO series events or other VIP tennis experience each year.

## Requirements of the School

In consideration of the School complying with its obligations, the School agrees to:

- a. ensure that all teachers, volunteers and other members involved in the running of the Program at the School comply with the terms of this Agreement;
- b. include tennis in the health and physical education curriculum for a minimum of 4 weeks each year. This can be achieved through use of a School teacher or an external coach (the cost of which is to be borne by the School);
- c. maintain its partnership with the Program Partner and if requested, allow the Program Partner to organise and run tennis lessons at the School;
- d. arrange for the primary contact (PE Teacher/Sports Coordinator) to participate in the free professional learning run by TA each year (either face to face workshop or online tutorial);
- e. form a student committee who will be responsible for ensuring that tennis equipment is available to students at lunch times at least twice a week, one term per year;
- f. organise and run at least one intra School tennis competition per year at the School utilising INTennisCITY (for example, during lunch time or after School at the end of the block of sessions);
- g. comply with the terms and conditions of the Australian Sports Commission's Sporting Schools program;
- h. comply with any Program guidelines and policies provided to the School by TA from time to time.
- i. ensure that all teachers, volunteers and other members involved in the running of the Program at the School obtain current Working with Children Checks (evidence of checks must be provided to TA upon request);
- j. comply with all reasonable directions issued by TA in connection with the Program;
- k. participate in all meetings and briefings reasonably required by TA;
- l. provide TA with information relating to the Program including student participation numbers when requested by TA.



## Obligations of the Program Partner

The Program Partner agrees to:

- a. work to create a strong partnership with the School, including acting as a support network and communicating regularly with the School;
- b. host a Free Tennis Day welcoming the School community (students and parents) for no more than 2 hours at the local tennis club as a pathway to connect the local tennis club and the School;
- c. obtain a current Working with Children Check and ensure that any contractors, employees or volunteers involved in the running of the Program at the School obtain current Working with Children Checks (evidence of checks must be provided to TA upon request);
- d. ensure all coaches involved in the delivery of the Program on behalf of the Program Partner meet Tennis Australia's screening, qualification and insurance requirements which include:
  - i. a current Working with Children Check;
  - ii. a satisfactory National Police Check;
  - iii. a current first aid certification;
  - iv. completion of the Keeping the Tennis Community Safe online tutorial;
  - v. completion of a Tennis Australia recognised qualification (List of recognised qualifications available at [www.tennis.com.au/doc/qualifications](http://www.tennis.com.au/doc/qualifications)); and
  - vi. completion of the Tennis Australia Tennis for Primary Schools Workshop
- e. provide material to the School to use for promotional purposes (e.g. company logo, event information; and gala day/event advertisement).

## Logo and Branding

TA grants to the School a licence to use the Program logo and images, in the form provided by TA in the branding suite (or any replacement logo notified by TA to the School from time to time) on the Schools website, in the Schools newsletters, and subject to the written consent of TA, in other approved marketing and promotional material for the Program. The School must only display, use or refer to the Program logo as approved by TA and in good faith so as to enhance and promote the goodwill and reputation of TA and the Program.

## Term and Termination

This Agreement commences on the date that it is signed by all parties and continues until it is terminated in accordance with this Agreement.

TA may terminate this Agreement immediately if:

- a. the School or Program Partner breaches any of their obligations during the Term and if the breach is remediable, having received written notice of the breach has not remedied the breach within 14 days;
- b. the School or Program Partner engage in conduct which has brought, brings or would have the tendency to bring TA or the sport of tennis into disrepute or, which is or would have the tendency to be inconsistent with, contrary to or prejudicial to the best interests, image or values of TA or its sponsors; or
- c. the Program Partner is no longer able to participate in the Program (for any reason).

If the School no longer wishes to participate in the Program it can terminate this Agreement by providing TA with 30 days written notice.

The Program Partner acknowledges and accepts that in the event the Program Partner's Working with Children Check is suspended or cancelled, or TA is made aware of any actual or alleged criminal activities by the Program Partner it believes are relevant, TA may in its sole and absolute discretion terminate this agreement immediately. TA may, in its sole and absolute discretion, also prohibit such Program Partner from participating in the delivery of TA programs in any other schools, now and in the future.

## Confidentiality

The School and Program Partner agree not to disclose any confidential details of the Program to any third party, except with TA's prior written approval.

## Assumption of Risk and Insurance

The School and Program Partner agree to carry and accept all risks in the running of the Program. The School and Program Partner must maintain professional indemnity insurance for an amount of \$10 million per claim and public liability insurance for an amount of \$20m per occurrence during the Term to the satisfaction of TA, and if requested, provide certificates of currency to TA. The School is responsible for ensuring that any teachers, coaches or other volunteers that are assisting with the Program are covered by the Schools insurance (or carry their own insurance).

## Privacy Statement

The School and Program Partner consent to TA collecting, storing, using and disclosing personal information in accordance with TA's privacy policy. A copy of TA's privacy policy can be found at [tennis.com.au/privacy](http://tennis.com.au/privacy).

## Consent to use of Image

In consideration of the Schools participation in a Program, the School consents, and agrees to procure the consent of all participants in the Program, to TA taking, retaining and reproducing images or likeness' obtained during the participants' participation in the Program at the School in photographs, electronic images, sound recordings and video footage and to use such images or likeness' for the purposes of any TA promotional, advertising, research or marketing materials (including for the promotion of the Program).
